

Auctioneers and the 13th Amendment by Mike Brandly, The Ohio Auction School



The 13th Amendment to the United States Constitution (Section 1) prohibits slavery and *"involuntary servitude."* As such, nobody can be forced to work for anyone else, including auctioneers. Specifically:

AMENDMENT XIII

Section 1. Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.

Section 2. Congress shall have power to enforce this article by appropriate legislation.

For instance, an auctioneer books a sizeable benefit auction but cannot conduct it so she notifies the organization that she will send another auctioneer in her place. The organization finds this out and seeks to sue the auctioneer they hired for *"specific performance."*

The argument is that the first auctioneer has breached the contract and should be required to perform as agreed, yet the 13th Amendment prohibits such remedy. However, the organization could sue if the replacement auctioneer's performance causes discernable damage.

For instance, the replacement auctioneer does a terrible job, selling items too quickly, missing bids, and making comments inappropriate for the event. The organizers guess this performance would have been enhanced by their original auctioneer by \$25,000, so they could potentially seek this \$25,000 from their original contractor.

I have heard for decades that auctioneers think they can make bidders bid, make buyers close, and make the most egregious terms and conditions binding — and now I'm guessing at least a few are equally happy to learn nobody can make them work for anyone else.

Lastly, however, what if an auctioneer hired a specific person knowledgeable about fine tuning automobiles in the auction, but this person didn't show up, instead sending an assistant? While the auctioneer can't order the specialist to *"specifically perform,"* if the assistant caused damages, the specialist may be liable.
